
Club Rules & Byelaws

Returning Larger Seatrout (Sewin)

All sewin (sea trout) larger than 66cm/26inches (approximately 8lb in weight) from the tip of the tail to the front of the nose (please see picture below) must be returned. The main reasons for this are: Larger sewin tend to be female, are usually multiple spawner's, and genetic studies show that larger, longer-lived Sea Trout produce young that are also likely to grow large; (for more information visit:

They are a precious resource and need our protection.



All Sewin (sea trout) larger than 66cm /26inches approximately 8lbs in weight caught on club water are to be returned alive to the river. Please see diagram above

Daily Limit:

No More than 2 migratory fish to be retained per angling trip;

If you kill 2 sewin: Any more fish caught must be returned.

If you kill 1 Sewin + 1 Salmon: Any more fish caught must be returned

If you kill 2 Salmon: Any more fish caught must be returned.

Only 1 angling trip per 24 hour period.

Salmon Season Limit:

No more than 3 salmon per season are to be killed by any Llandeilo Permit Holder.

The Executive Committee have brought in these rules to ensure that we as CPLIAA are at the forefront of fish conservation in the Tywi valley. We do not support total Catch and Release, and feel that anglers should be able to take a fish or two home to enjoy. However research shows that some fish that run our rivers are of more value to us as anglers in the river, than on our tables. We are asking you to follow these rules as our attempt at ensuring salmon and sea trout angling for future generations.

New Rules for Fishing the Baskets Pool: Odd and Even Permits

Fishing the pool is based on the calendar month. So if you have an even ticket/permit number you will fish on an even date say the 8th, 10th or 12th and visa versa for odd ticket/permit numbers.

With regards to Night fishing, here is an example: if you wish to night fish on the 12th and have an even number ticket, you may fish through until the morning of the 13th. However you will not be allowed to return to fish the Baskets on the evening of the 13th. Daylight fishing is date dependant, for example if a flood arrives on 14th of June only evens permit holders may fish the Baskets, that day.

The Baskets pool gets very heavily fished and this rule is aimed at reducing the number of anglers who fish it daily. Do not forget we have a further 8 miles of river which offers very good fishing, which you may fish whenever you wish.

Finally this rule will be enforced for the 2017 season, and the club will take action against those who do not follow it.

Cymdeithas Pysgota Llandeilo Angling Association Cyf. Club Rules 2017

- 1. Annual subscriptions shall be paid before the 1st of April and before fishing. Any member or permit holder not paying by this date shall be deemed to have resigned and the next eligible applicant on the waiting list shall be admitted to the association.
- 2. All applications for membership shall be in writing to the secretary. The committee will approve or reject all applications, and the committee's decision is final.
- 3. Fair angling by rod and line only shall be permitted and any member guilty of misconduct or impropriety or of any unlawful practice shall not be invited to hold a ticket by the executive committee.
- 4. Anglers must act in a polite and sporting manner whilst fishing association waters
- 5. No permit holder shall be allowed to take a dog with them whilst fishing Associations waters
- 6. Deadbaiting with live bait or with lures of any kind is prohibited.
- 7. The Executive committee will decide entrance fee and permit fees.
- 8. No member or licensee may take a vehicle on to land of any farmer or other person through whose land the waters owned or tenanted by the Association without landowner permission.
- 9. Any permit holder found guilty of leaving a railway or any other gate open will not be re-invited to hold a permit by the association.
- 10. Any Bailiff (NRW) or Association bailiff, permit/ticket holder upon producing his permit/ticket may demand to see the permit/ticket/licence of any angler fishing club waters
- 11. Permits issued to anglers must be carried by them at all times on their own person whilst fishing, otherwise it is justified in asking them to leave the river bank.
- 12. Shrimping and Prawning are prohibited on all Association water's, anyone doing so will be expelled forthwith.
- 13. The use of lines, excluding casts not exceeding casts three metres in length of a breaking strain less than 8 pounds is prohibited.
- 14. Any member or permit holder who takes a tenancy or attempts to take a tenancy of the Associations water shall be expelled forthwith.
- 15. Any member who is refused a permit by this Association for reasons where he/she had been expelled for violating any one of these rules is also debarred from joining other Associations or club who is a member of WSTA.
- 16. All complaints must be made in writing to the committee.
- 17. Children under 16 must be accompanied by an adult on the river bank, apart from the designated area at Llandeilo Road Bridge, which is only available for juniors and senior citizens.
- 18. All sea trout caught after the 1st of September on association waters must be returned.
- 19. There is a limit of only 3 Salmon in any one season.
- 20. Only 2 migratory fish are to be killed in a 24 hour period: e.g. If you kill 2 fish by 10am on a Tuesday morning you may not kill any more salmon or sea trout until 10am the following Wednesday, but you may practice catch and release.

All Sea Trout over 8lb (3.6kg) 66cm/26 inches in length are to be returned to the river immediately and carefully.
